ENROLMENT OF ORDER

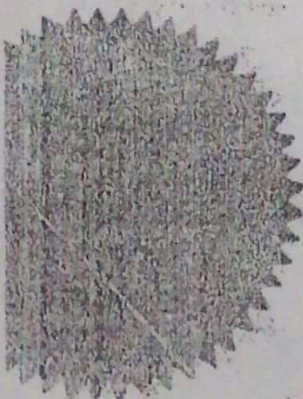
UPON THIS MATTER coming before this Honourable Court.

JUDGMENT IS HEREBY ENTERED AS FOLLOWS:-

1. IT IS HEREBY DECLARED that the Claimants Family - OGBONI FAMILY OF AKODO VILLAGE, IBEJU LEKKI are the persons entitled to the grant of a Statutory Right of Occupancy over the excised land described in Exhibit D5 -






the Notice of Excision as AKODO VILLAGE PARCEL A, and AKODO VILLAGE - PARCEL B respectively.

2. The 9th Defendant shall issue a Certificate of Occupancy on the said excised land in favour of the Claimants Family.
3. The Memorandum of Agreement Exhibit C21 dated 20th day of November, 1995 is hereby nullified.
4. Any Sale or other alienation of whatsoever nature of any portion of the said excised land by the 1st to 3rd and 5th to 7th Defendants, to the 4th Defendant or anybody whatsoever is hereby declared null and void and of no effect whatsoever.
5. Possession of the said excised land is granted to the Claimants in this suit.
6. An Order of perpetual injunction is hereby made restraining the 1st to 3rd and 5th to 7th Defendants whether by themselves, their servants, agents or privies or whosoever from alienating, transferring, selling, assigning or exercising any rights on the said excised land.
7. N250, 000 cost of this action to the Claimants against the 1st to 3rd, 4th to 7th Defendants.
