Q1. WHERE IS BOULEVARD ALCAZAR?

BOULEVARD ALCAZAR is situated at IDERA HOUSING SCHEME, ELEKO, IBEJU-LEKKI LGA, LAGOS STATE

Q2. WHY SHOULD I BUY BOULEVARD ALCAZAR?
